Endowment honors lasting service of Regent Leebern

Regent Emeritus Donald M. Leebern Jr. served on the Board of Regents from 1991–2019, where he provided needed philanthropy, including generous support of athletic



programs, student scholarships, and the Embark@UGA program for students who have experienced homelessness or foster care, among other areas of financial support.

As an expression of appreciation, an endowment supporting need-based student scholarships was created at the University System of Georgia Foundation honoring Regent Leebern and his 28-year service on the Board of Regents where he dedicated his time, talent and service to the state of Georgia and the cause of higher education.

During Regent Leebern's tenure on the Board of Regents, the University System of Georgia strengthened its academic reputation and grew enrollment dramatically, with a more than 70 percent increase befitting one of the largest and best public higher education systems in the nation.

Scholarship offers support for Troup County students

Former UGA basketball star, now athletic director at UVA, establishes need-based fund named in tribute to parents

Dr. Carla Green Williams honored the legacy of her parents, Barner and Johnnie Mae Green, of LaGrange, Georgia, by establishing an annual scholarship fund to financially support students from Troup County, Georgia, as they further their



education at a USG institution.

Dr. Green serves as the athletic director for the University of Virginia. A self-described "gym rat from the time I was 8 years old," she spent many hours practicing on the basketball courts of LaGrange. Named the "best high school player in the state" in 1985, Dr. Green went on to become a star on the court at the University of Georgia.

Following her collegiate athletic years, she was quickly promoted to athletic administration

positions at Florida State, Vanderbilt and UGA before being named as the first African-American woman to lead a major college program at UVA.

Dr. Green never forgot her hometown of LaGrange or the values she was taught from her parents and many family members who lived throughout Troup County. She wanted to give back to "her hometown" by establishing the Barner and Johnnie Mae Green scholarship.

Endowment Highlights

Introduction

Endowed assets gifted to the USG Foundation are managed by our Investment Advisor, Truist (formerly SunTrust) Foundations and Endowments Specialty Practice. Truist focuses on delivering strong, longterm performance and high-quality stewardship of the Foundation's endowment funds. Our long-term perspective enables close alignment with a shared objective: that the institution is well-supported to serve the current generation and countless generations to come.

Investment Goals

For endowed funds to remain impactful, the goal is to preserve purchasing power over the long term. To accomplish this objective, the investment return seeks to outpace the spending rate and inflation, while minimizing risk by diversifying broadly across major asset classes. Additionally, the endowment pool invests in public and private markets to achieve further diversification benefits.

Spending Plan

Endowed funds are designed to provide a relatively stable and consistent stream of income to support the Foundation for as long as the fund exists. Because the endowment pool performance fluctuates in the short term, the Foundation uses a spending policy to help stabilize the income stream over time. Our spending policy currently distributes 4-5 percent of the endowment's average market value over the previous 12 guarters. The Foundation's board of directors reviews the spending policy and the endowment pool's investment performance annually. The current return objective, also reviewed annually by the board with our Investment Advisor, is to achieve an annualized return of CPI plus 4 percent (spending draw) over a trailing three- and five-year period, to measure the real purchasing power of the endowment over time.

Commitment

The USG Foundation is focused on responsibly stewarding and investing philanthropic gifts. In addition to the ongoing responsibility of monitoring the

asset-allocation targets and annually reviewing the current long-term expected return, the Foundation is committed to a cost-conscious investment operation. The focus continues to be on investing gifts received so that their impact is meaningful and transformative for many years to come.



Growing the Endowment

In FY '20, the USG Foundation continued to build its endowment to support student scholarships, faculty awards for quality teaching and research, and USG academic initiatives. Endowments are a critical factor in the long-term stability of funding for public higher education. By continuing to focus on increasing this important resource, the USG will continue to thrive even in times of financial uncertainty with fluctuating state and federal funds.

The USG Foundation remains committed to partnering with donors to grow contributions to the endowment. Recent gifts made by generous financial contributors demonstrate confidence in the direction of public higher education in Georgia.
